Assessor's Report:

Mark Maki reports that he is in correspondence with the STC regarding the audit results. Fields check updates are being done. He will be taking training on the State Tax Commission updates which is required training hours for 2026.

Planning Commission:

Mark Maki reports that he has sent letters to the following property owners requesting corrective action by July 9, 2025. Nicole Clark, M-94- No Permit, Bo Morton-McMaster Rd-second dwelling mobile home not yet removed. Robert Lajoie-Dukes Rd. —no permit, Lyndsay Bleau-100 Valli Rd.-structure not meeting setbacks, Shane Walter-Forest Rd- no permit. Will contact Charles DeVooght regarding site plan for Farmer Market-DeVooght Store-needs zoning for lot north of store used for storage of items for sale. Next Planning Commission meeting is scheduled for August 7, 2025. The Zoning Board of Appeals approved a variance for Andrew Nieman for a detached garage setback.

Blight Complaint:

Letter has been sent to Mr. Gallant by email and certified letter. The certified letter came back refused. A. Erickson will contact the person who did complaint to let her know what has been done.

JOB Agreement:

Townline Road:

A. Erickson met with the County Road Commission to go over the invoice for Townline Rd.and she got the price of the road reduced to \$10,000. It was suggested that we write up something for West Branch Township to sign stating that they will be responsible for payment on the second portion of the road when it is done.

The budget report was reviewed and will be placed on file.

Mowing Park:

A price quote was received from Every Season Property Maintenance for mowing the Skandia Township Park and the Transfer Facility. M. Keto stated that she knew of someone that would mow the Transfer Facility for putting in donated time for community service. The park quote was discussed and it was suggested that we contact Travis and ask what he would charge for just mowing the park. Will discuss further at our July meeting when we get new price.

Correspondence:

MCSWMA – regarding letter stating tipping fees will be going up to \$87.00 per ton starting July 1, 2025.

Payment of Bills:

Motion by B. Bray seconded by M. Keto to pay the bills for June 2025 totaling \$16,762.74 Motion **CARRIED.**

Payment/JOB Bills:

Motion by B. Bray, seconded by L. Linna to pay the JOB bills for June 2025 totaling \$43,320.71 Motion **CARRIED.**

Public Comment:

M. Keto stated that there will be a Gwinn School Election in November 2025. Mark Krans asked if a weed burner would be effective in burning the grass in between the park fences. B. Bray said that there will be a Texas Roadhouse Fundraiser on Monday, August 25th from 3-7 PM. Ten percent of all food purchased will be donated to the Skandia Lions Club.
